Other types of facilities covered by the ADA are subject to similar ADA Standards issued by the Department of Justice. Both the DOT and DOJ standards are based on the Board's ADA Accessibility Guidelines.

ADA transportation is for people whose disabilities prevent them from using the regular accessible WRTA fixed route bus for some or all of their trips. The WRTA determines eligibility based on functional considerations and helps determine which individuals can most benefit from ADA paratransit service and which individuals can be best served by the regular accessible WRTA fixed route bus.

What is ADA Transportation? - WRTA Paratransit

The Department of Transportation has issued regulations mandating accessible public transit vehicles and facilities.

The regulations include requirements that all new fixed-route,

Service characteristics: In general, ADA complementary paratransit service must be provided within 3/4 of a mile of a bus route or rail station, at the same hours and days, for no more than twice the regular fixed route fare.

The ADA guarantees people with disabilities equal access to public transportation. This means that public transportation providers cannot refuse to provide you with transportation

because you have a disability. You cannot be required to transfer to a seat. You also cannot be required to use “priority” seating on a bus or transit vehicle.

The ADA and Public Transportation - Legal Aid at Work
The Department originally published its ADA title II and title III regulations on July 26, 1991, including the 1991 ADA Accessibility Guidelines (1991 Standards). On September 15, 2010 the Department published final regulations revising the Department’s ADA regulations , including the adoption of updated ADA Standards for Accessible Design (2010 Standards).
